### APPLICANT'S STATEMENT

1. I declare as follows:

- 1) that the information in my scholarship application and its attachments is truthful, and that the content of the scholarship application and its attachments does not violate the copyright and personal rights of third parties;
- 2) that I hereby agree to participate in the scholarship application process;
- 3) that I agree to send correspondence by electronic means within the meaning of Article 2(5) of Poland's Act of July 18, 2002 on Providing Services by Electronic Means (Journal of Laws of 2022, item 344) to the e-mail address provided in the scholarship application;
- 4) that I fulfil the obligations in Article 13 or Article 14 of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of individuals with regard to processing personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L 119 of 04.05.2016, p. 1, as amended) towards natural persons from whom I have directly or indirectly obtained personal data for the purpose of applying for a scholarship;
- 5) that I am not a member of any entities listed in Article 7 (1) of the Law of April 13, 2022 on preventing support for aggression against Ukraine and protecting national security (Journal of Laws of 2024, item 507, as amended).
- 6) I condemn the Russian Federation's aggression against Ukraine launched on February 24, 2022.

2. Pursuant to Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (Dz. Urz. EU L 119, 04.05.2016, p. 1, as amended), hereinafter referred to as "RODO", and Articles 3-5 of the Act of May 10, 2018 on the Protection of Personal Data (Journal of Laws of 2019, item 1781), I acknowledge the following:

- 3) that my personal data will be processed under Article 6(1)(c) of RODO for the purposes related to this scholarship application, including finalising the scholarship agreement and controlling its execution
- 4) that recipients of my personal data may be entities that have the right to request access to such data under laws applicable in the Republic of Poland, as well as entities providing services to the Juliusz Mieroszewski Dialogue Centre, including postal, IT or telecommunications services, as well as legal and debt recovery services;
- 5) that my personal data will be kept for the period of the scholarship procedure and then archived as prescribed by law;
- 6) that the obligation to provide my personal data directly concerning me is a statutory requirement in the Act of March 25, 2011 on the Juliusz Mieroszewski Centre for Dialogue (Journal of Laws of 2023, item 96 and 2024, item 1089) and the Decree of the Minister of Culture and National Heritage of July 6, 2023 on scholarships under the scholarship programmes of the Juliusz Mieroszewski Centre for Dialogue (Journal of Laws, item 1446) and in the regulations of the scholarship programme entitled "A month in Poland" as related to the present scholarship granting procedure; and that the consequences of failure to provide requested data will be as specified under that legislation;
- 7) that with regard to my personal data, decisions will not be made by automated means as under Article 22 of the DPA;
- 8) that I have:
  - a) under Article 15 of the RODO, the right to access my personal data;
  - b) under Article 16 of RODO, the right to correct my personal data;  
*(the exercise of the right of rectification shall not result in a change of the result of the scholarship granting procedure or in a change of the provisions of the scholarship agreement in the scope inconsistent with the Act of 25 March 2011 on the Juliusz Mieroszewski Centre for Dialogue (Journal of Laws 2023, item. 96 and 2024, item 1089) and the Ordinance of the Minister of Culture and National Heritage of 6 July 2023 on scholarships within the framework of scholarship programmes of the Juliusz Mieroszewski Centre for Dialogue (Journal of Laws, item 1447) and in the provisions of the Regulations of the scholarship programme entitled "A month in Poland", and shall not affect the integrity of the report and its appendixes);*
  - c) under Article 18 RODO, the right to request the controller to restrict the processing of my personal data, subject to the cases referred to in Article 18(2) RODO; *(the right to restrict the processing does not apply in relation to storage, in order to ensure the exercise of legal remedies or to protect the rights of another natural or legal person, or with regard to compelling grounds of public interest of the European Union or of a Member State);*
  - d) the right to lodge a complaint to the supervisory authority as defined in the RODO, ie the President of the Office for Personal Data Protection, if I consider that processing my personal data violates the provisions of RODO;
  - e) under Article 38 (4) of RODO, the right to contact the Data Protection Officer at the Juliusz Mieroszewski Centre for Dialogue on all matters related to my personal data;
- 9) that I am not entitled to:
  - a) under Article 17(3)(b), (d) or (e) of RODO, the right to erasure of my personal data;
  - b) the right to portability of personal data, as in Article 20 of RODO;
